Jason Watts, Chief Operating Officer, reviewed contract and need for sprinklers at Scholarship Prep - Oceanside. In order to increase enrollment 50% for the Grant funding. General Manager at San Luis Rey said if we would pay 50% of the cost they would pay other 50% to install sprinklers in the additional rooms that we need to increase population to 480 students. We need 479 students a year from now. We were denied the Prop 39 Material Revision by the County of San Diego. There is no possibility of a revote.
