#### 7.0 INFORMATION SESSION

#### 7.1. Executive Director Report - Sen. Gloria Romero (Ret.), Executive Director.

Sen. Romero highlighted three items in her report to the Board. She briefed the Board on Scholarship Prep Oceanside's participation at the National School Choice Week celebration held at the Queen Mary. Also participating in the event were Board Members Birchler and Burgess.

Romero provided an update on the submission of the Los Angeles County Office of Education charter petition appeal of the proposed Palmdale charter and a potential consolidation with another charter school in Los Angeles.

Finally, she informed the Board of the Santa Ana campus being named a California Distinguished School and the Award Ceremony.

#### 7.2. Principal's Message - Harris Luu, Scholarship Prep South Bay Principal.

Mr. Luu provided updates on enrollment, attendance, and community engagement at the South Bay campus. He also announced 3rd grade teacher, Diana Ashbaugh, as Teacher of the Year and 6th grade student, Keyra Morales, as Student of the Year.

Joining Mr. Luu was Pep Squad President and School Site Council member, Ms. Rivas, who provided an update on school fundraisers, spirit events, parent volunteer planning, and her commitment to create a strong sense of community at Scholarship Prep South Bay.

# 7.3. Comprehensive School Safety Plan Overview and Presentation - Andrew Crowe, Chief Academic Officer.

Mr. Crowe, Chief Academic Officer, presented a Comprehensive School Safety Plan. He explained that the contents of the Comprehensive School Safety Plan are required by the State of California to ensure the operation of the organization. Mr. Crowe discussed various policies and training for staff to support this process. He highlighted identified areas and items listed in the plan that need Board approval.

# 7.4. Scholarship Prep Principal and Teacher Evaluation Process Presentation - Andrew Crowe, Chief Academic Officer.

Mr. Crowe, Chief Academic Officer, presented the process by which Scholarship Prep principals and teachers will be evaluated for promotion and retention, and underscored the background research supporting the chosen evaluation process. He reviewed various elements that will be utilized to observe and thoroughly evaluate an administrator or teacher, and the crucial points being evaluated in a classroom setting.

Dennise Allotey, Scholarship Prep Santa Ana Principal, shared the results and success of student surveys.

#### 7.5. Update of Scholarship Prep Santa Ana Monthly Financial Report.

Paul Khoury from DMS participated in the meeting via phone and provided an executive summary and overview of the financial report that showed a healthy budget for Santa Ana campus.
