School Expansion Updates Coronavirus Health Warnings State of the State on Homelessness 2019 - 2020 Form 700's

Romero provided a brief update on school consolidation expansion efforts with high performing charter schools along with information regarding the submission of the Los Angeles County Office of Education charter petition appeal of the proposed Scholarship Prep Palmdale campus.

Romero briefed the Board on the material revision submission of the Orange County Department of Education and public hearing in efforts to expand our programs in Orange County and include Homeless Youth as part of our Countywide focus and expanding those programs through high school. Romero announced the upcoming Annual Foster and Homeless Youth Summit scheduled at the end of April. Romero informed the Board of the recent declaration of a Local State of Emergency in Orange County by the Board of Supervisors as a preventative measure for the Coronavirus outbreak. She touched on the steps that were preemptively initiated with our scholars and families.

Romero also discussed the recent State of the State remarks on homelessness by Gov. Gavin Newsom and how it connects with our current Material Revision.
