# Executive Director Report - Sen. Gloria Romero (Ret.), Executive Director.

- Coronavirus Update/Distance Learning
- Los Angeles County Board of Education Palmdale Appeal

Sen. Romero gave a Coronavirus update. The governor's mandate for closure is still in effect until the end of the school year. Sen. Romero indicated that the school sites will be closed to students and the public through the end of the school year, but that learning is continuing via our Distance Learning program with strong teacher outreach to Scholarship families, scholars. The schools are still serving boxed breakfasts and lunches to students. Andrew Crowe gave an update on the Distance Learning program.

Sen. Romero reported that the Los Angeles County Board of Education (LACOE) Board denied the Palmdale appeal petition 5-2 (Boyd & Rosenberg approving appeal) on April

14th. On April 15th, the Orange County Board of Education unanimously approved (5-0) the Material Revision for SP-Santa Ana to add a high school.
